## Employer Delinquency List

Employers are required to submit reports and pay contributions for every month work is performed. Reports and contributions are due on or before the 15<sup>th</sup> day of each month immediately following the month work is performed. An Employer is also required to submit a “zero hour” report by the 15<sup>th</sup> day of each month immediately following a month no work is performed. An Employer is delinquent if the reports or contributions are not received by the Fund Office by the due date. If an Employer is delinquent, the Employer will be notified in writing, electronically or by telephone, and may be added to the delinquency list.

Employers on the delinquency list are (1) Employers that are at least sixty (60) days delinquent in submitting reports or paying contributions to the Fund Office; or (2) Employers that have been notified of unpaid contributions and have not timely remitted payment of the contributions to the Fund Office.

If an Employer believes that it is on the delinquency list in error, please contact the Fund Office immediately. Please also forward all records showing that all reports were submitted, and all contributions were paid, and include a copy of each report, along with a copy of the front and back of the canceled check used to pay the contributions. This will help the Fund Office verify receipt of the reports and payment of contributions, and expedite the removal of an Employer on the delinquency list in error.
